Copyright Basics Overview


Copyright protects original works of authorship fixed in a tangible medium of expression.

Exclusive Rights under § 106:

- Reproduce
- Prepare derivative works
- Distribute
- Publicly perform
- Publicly display
- For sound recordings: publicly perform by means of digital audio transmission.

Public Performances: Films

Could fair use apply?



Define "publicly"

To perform or display a work publicly means

- (1) To perform/display in a place open to the public or any place where a substantial number of persons outside a normal circle of family or social acquaintances is gathered; or
- (2) To transmit or otherwise communicate a performance/display of the work...by means of any device or process...whether received in the same place or in separate places and at the same time or at different times.



Examples of public performances

- A student group has organized a film screening in a location where public access is not restricted.
- A student group would like to show a film as a fundraising event, open to the public.
- An academic unit would like to show a film as part of a larger program for members of the community.





Do you need a license?

- Is this a public performance that does not fall under a statutory exception?
- Does your institution already have public performance rights (PPR) for the film?
 - o What uses are covered?
 - O What limitations?
- Is a license already provided through the copyright owner?
 E.g., some Netflix titles

Requesting a public performance license

- Who? Copyright owner (producer/studio) or authorized entity.
- Including:
 - Swank Motion Pictures
 - Criterion Pictures
 - Motion Picture Licensing Corporation (blanket license)



But I have a Netflix account!

- Netflix Terms of Use: "The Netflix service and any content viewed through our service are for your personal and non-commercial use only...You agree not to use the service for public performances."
- Hulu Terms of Use: "You may only access and view the Content personally and for a non-commercial purpose..."
- Amazon Video Terms of Use: Amazon grants a non-exclusive license "to access and view the Digital Content...for personal, non-commercial, private use..."



Public Performances: Music



Copyrights involved

Some uses of music may involve two copyrights:

a copyright in the musical composition and a copyright in the sound recording.



Examples of public performances

- Concerts from student/faculty ensembles Concert Band, Glee Club, Symphony Orchestra, etc.
- Live performances made on The Oval, student union, and buildings on campus.
- University sponsored concerts.
- Other live events.



Does a statutory exception apply?

Do you need a license?

Does your institution already have a public performance license for the music? Will this license cover the request?



Sec. 110(4): Non-commercial performances

- Covers performance of nondramatic musical works made without any purpose of direct or indirect commercial advantage and without payment to performers/promoters/organizers, if:
 - 1. No direct or indirect admission charge, or
 - 2. Proceeds used exclusively for educational, religious, or charitable purposes and appropriate notice of objection from the copyright owner has not been received.



Public Performance License

 Blanket public performance licenses offered through 4 major PROs.










 Scope: Nondramatic performances of musical compositions within respective repertory made on the Licensee's premises.



Other Considerations

- Some uses may involve other licenses- e.g., synchronization or mechanical.
- Public performance right in sound recordings is only for public performances made via digital audio transmission.
- Public performance for pre-1972 sound recordings?
